- Lay candidates are now allowed to take their Fourth Degree Exemplification in a business suit which, meets the following criteria:
- The suit can be black, dark blue, or dark gray.
- The shirt to be worn will be white, long sleeve, no cuff links, and have a laydown collar.
- NO BUTTON-DOWN COLLARS. Tie must be black, dark blue or the red Knights of Columbus tie.
- Shoes will be black, shined, with plain dark socks.
- Military and First Responders may wear their dress uniform.
- Clergy are encouraged to wear their clerical attire.

- Lapel Pin will be issued to each candidate, BUT NOT WORN, BEFORE THE CEREMONY.

Application:
